7. The employee(s) will be required to carry out duties either of post of **Suptdg.Engr.(Cmtg)** or of the lower post depending upon exigency of work, irrespective of new designation. If at any time it is found that they have refused to carry out duties assigned to them, they will be liable to face disciplinary action besides reversion to the lower post.
