Sub – Issues of Western offshore pertaining to Organization and Welfare of Officers

Ref: ASTO Mumbai letter vide no. ASTO/Mum/Meeting/20/2021 dated 17.09.2021

Respected Sir,

This is in continuation of referred letter (Copy Attached), where ASTO Mumbai had requested for a meeting with your kind self on the agenda points attached. The meeting is still awaited and some additional issues have developed during this period. These issues need your immediate intervention to resolve to the satisfaction of offshore employees. Additional issues are as follows:

1. Compensation for extended duties performed beyond 14 days during Covid-19 Pandemic from March 2020.
2. Treatment of balance off.
3. Field allowances.
4. TA condonation:
 - a. Self-health issues:
 - i. Employee got sick, DE boarded from offshore before completion of minimum duty period required for TA claim.
 - ii. Employee De-boarded due to Covid positive or contact tracing and had to remain quarantine in Mumbai, thereby couldn't complete the minimum duty period required for TA claim.
 - b. Shift adjustment due to regular change in Duty pattern.
5. Extension of validity of ODL circular issued.
6. Provision of Al-a-Carte facility for employees quarantined at Hotel.
7. Stoppage of RT-PCR testing before mobilization of crew to offshore in view of recent guidelines from Govt. of India.
8. Demolition and fast track Construction of Santacruz Guest House. In the meantime option may be explored to hire a building to develop as Guest House.

Sir, it would be our great pleasure to have a meeting of ASTO office bearers with you to discuss these issues.
