Respected Madam,


This is with reference to aforementioned circular where the amount of support and contribution under ONGC Composite Social Security Scheme has been revised with effect from 01.01.2022 instead of due date 01.06.2021. The issued order needs modification according to defined periodicity of 5 years to cover the families of beneficiaries from the period of 01.06.2021 to 01.01.2022. Here, I would like to draw your kind attention towards the summary of the orders issued earlier which are as under:

In order no. ONGC/ER/CP/TRU/002 (53/2006), dated 26.09.2006, it was clearly mentioned that the scheme would be reviewed after a period of 5 years. Even though, the review of the scheme were delayed beyond scheduled period at some instances, **the effective date was always maintained as 5 years from earlier effective date.** In the spirit of committed periodicity of 5 years and in the interest of beneficiaries, it will be justified if the effective date of the order no. 02/2022 dated 05.01.2022 is rectified to 01.06.2021 and final payment be made by recovering additional contribution due out of the amount payable in such cases. The corrective action in this regard will provide justice to the families of eligible employees.

Accordingly, necessary instructions may please be issued to the concerned authorities.
